RESEARCH & ANALYSIS

Aimed Alliance conducts research and provides analysis on its policy priorities, including reforming the healthcare system so that all Americans have comprehensive health insurance coverage, improving patient access to quality care, preserving the practitioner-patient relationship, and addressing the drivers of health care costs. Aimed Alliance's findings culminate in reports, fact sheets, brochures, legislative maps, and comments to government entities. Legislative & Regulatory Activity

Copay Accumulator Programs

- Comment: To U.S. Department of Health and Human Services (HHS) and the Centers for Medicare and Medicaid Services (CMS) on the Notice of Benefit and Payment Parameter (NBPP) 2022 and letter asking HHS and CMS to freeze the NBPP 2022 and reinstate limitations on copay accumulator programs
 - Successfully obtained call with CMS, HHS, and the Consumer Information and Insurance Oversight (CCIIO) to discuss concerns
- <u>Comment</u>: To HHS and CMS on Medicaid Best Price Rule
- Letter: Asking HHS and CMS to freeze and revoke recent changes to Medicaid Best Price Rule
 - Successfully obtained call with CMS, HHS, and CCIIO to discuss concerns
- Letters: In support of state copay accumulator bills in 11 states (Maryland, New Mexico, Connecticut, Kentucky, New York, Nebraska, South Dakota, Oregon, Ohio, Tennessee, & Utah)
- <u>Comment</u>: To HHS in response to "Request for Information Regarding Reporting on Pharmacy Benefits and Prescription Drug Costs"
- Letter: To CCIIO on Non-Essential Health Benefits schemes
 - Successfully obtained call with the regulatory agencies.
- Fact Sheet: IRS's 2004 Notice Should Not Prevent Copay Accumulator Reform

Step Therapy & Prior Authorization

- Letter: To <u>Massachusetts</u>, <u>New Jersey</u>, and <u>Rhode Island</u> in support of step therapy legislation

Value, Innovation, & Drug Pricing

- <u>Comment</u>: To CMS on Most Favored Nations Rule
- Letter: To Connecticut in support of legislation to prohibit payers from using QALYs in developing thresholds for treatments
- Letter: To Louisiana in opposition of SB 181, which would permit nonmedical switching based on drug price inflation

THOUGHT LEADERSHIP

Using its research and analysis, Aimed Alliance develops sound, patient-centered policy recommendations. Representatives for the organization disseminate Aimed Alliance's analyses and recommendations by presenting to audiences of patients, advocates, practitioners, associations, human resources professionals, industry members, and policy makers; and engaging with the news media. In 2021, Aimed Alliance's thought leadership included the following activities:



Aimed Alliance-Led Initiatives & Coalitions

New York Step Therapy Initiative

- Recruited over 20 groups to participate in regularly scheduled policy and advocacy meetings
- Developed 11 fact sheets (additional protections for chronic disease states; increased data collection, reporting, and transparency requirements; appropriate clinical peer review; strengthening enforcement and patient protections to deter violations; dermatology, gastroenterology, hematology, neurology, oncology, ophthalmology, rheumatology)
- Drafted model legislative and regulatory language
- Obtained two calls with Department of Financial Services (DFS) to discuss concerns about insurers' compliance with existing step therapy requirements
- Scheduled and participated in meetings with state legislators

Know Your Rights

- Maintained <u>website</u> that contains information on how to file an insurance appeal in each state
- Developed <u>brochures</u> to educate patients and providers on how to file an insurance appeal in each state
- Successfully assisted individual patients to access their medications by providing guidance and recommendations on interactions with health insurers and pharmacy benefit managers



Alliance for Mental Health Care Access

- Sent <u>sign-on letter</u> to CVS requesting that the pharmacy benefit manager not engage in non-medical switching of patients with depression (obtained 11 sign-ons)
- Developed a digital influence campaign targeted at six CVS decision-makers; overall, the influence campaign generated 99,600 impressions, and 444 clicks
- Created letter forms for patients and patient advocates to send to CVS executives, which generated 370 letters to each of the six CVS decision-makers
- Developed a <u>video</u> asking CVS not to leave patients with depression in the dark during the pandemic, which garnered 4,493 views
- Published op-ed in <u>RealClear Health</u>
- Held first meeting, "Non-Medical Switching & Mental Health: Ensuring Access to Appropriate Care" and released <u>Executive Summary</u> of meeting
- Sent a <u>letter</u> to Senators Wyden and Crapo regarding their request for information on improving mental and behavioral health care access.

ACTION for PDTs

- Created <u>website</u> and opt-in form
- Developed a multidisciplinary collaboration with like-minded organizations interested in advocating to expand access to and coverage of prescription digital therapies for individuals with chronic conditions. See collaborative prospectus <u>here</u>
- Developed first ACTION for PDTs working group focused on unique barriers faced by patients with mental health and substance use disorder in accessing prescription digital therapies
- Hosted and produced an <u>executive summary</u> for ACTION for PDTs Kick-Off Webinar: Addressing Chronic Diseases, Mental Health, and Substance Use Disorder: Optimizing Care with Prescription Digital Therapeutics
